Section 3.24 USE OF RECREATIONAL VEHICLES AS ADU (additional dwelling unit)

- 1. Recreational vehicles that are licensed and insured, fully self-contained and less than ten years old, CAN be occupied between April 1 and October 30 as an ADU if set on a gravel or concrete pad with sewer, water and electrical hookups.
- 2. All site improvements require permits and inspections.
- 3. Property owner must apply for an annual permit with the City of White Cloud, stating Recreation Vehicle make, model, year, license number, proof of insurance and names of occupants. Occupants must be parents or children of Owner.
- 4. Zoning Administrator will make inspection prior to occupancy.
- 5. The limit of RV ADU permits in the city will be designated by City Council on a yearly basis.

6. Annual permit fee will be \$50.
