F. City Manager Report

- MDOT Street Grant: Newaygo County Road Commission confirmed November 18, 2019, the James Street project will not be completed this fall. Rieth Riley will do as soon as possible in the spring.
- Hope Network Option Agreement has been signed for the property on Pine Hill. We will discuss later in meeting.
- City, Township, Village Revenue Sharing Incentive Program is an annual report required by State of Michigan Department of Treasury in order to receive a portion of the statutory funds that were discontinued around 2010. The detailed reports are available at the City office and on our website.
- Water tower communicating system is not operating at full capacity. Replacement system has been ordered; it will be two to three weeks for delivery & installation. DPW staff is manually activating the filling of the tanks, it will cause overtime for our DPW department.
- Dam Safety Inspection Report was received.
- Department of Insurance & Financial Services: The City will continue participating in the Fire Insurance Withholding Program. The program allows the City to hold in escrow, an amount up to 25% of the property owner's insurance collection to ensure the property cleanup meets the zoning standards.
- MDOT state trunk line permit filled out and approved.

I. New Business

1. Proposed Property Sale Agreement

The City has entered into an option agreement to sell a vacant piece of property adjacent to the City offices to Hope Network. The City did not engage in any bid process for the sale of Parcel before signing the option agreement.

Michigan statue nor the common law require a municipality to engage in a public bid process before selling municipal real property.

Section 6.24 of the City Charter provides in relevant part as follows: [1] In all sales or purchases in excess of \$500.00, the sale or purchase shall be approved by the Council, and formal sealed bids shall be obtained unless the Council by formal unanimous resolution of those present at the meeting determine that no advantage to the city would result from competitive bidding. The Council may authorize the making of public improvements or the performance of any other city work by a city agency without competitive bidding. The Council may establish detailed purchasing, sale and contract procedure by ordinance or resolution.

Motion by LeBlanc, Seconded by Scott to confirm, validate and approve the grant of an option to Hope Network to sell the parcel next to City Hall without utilizing a public competitive bid process as no advantage to the City would result from competitive bidding for that matter.
