

**CITY OF WHITE CLOUD
NEWAYGO COUNTY, MICHIGAN
Ordinance No. 2019-01**

At a regular meeting of the City Council for the City of White Cloud held at City Hall, 12 N. Charles in White Cloud, Michigan, 49349 on May 7, 2019, the following Ordinance was offered for adoption by City Council Member Chandler, and was seconded by City Council Member Fessenden:

**AN ORDINANCE OF THE CITY OF WHITE CLOUD, MICHIGAN REGARDING
SMOKING AND VAPING BEING PROHIBITED.**

Intent: An ordinance "Smoking and Vaping Prohibited" for the purpose of protecting the public health and to encourage healthy behaviors of the citizens of White Cloud, Michigan and for the purpose of providing for the violation thereof,

THE CITY OF WHITE CLOUD ORDAINS:

The following ordinance provisions are hereby adopted by the City of White Cloud Council and will constitute a new Ordinance entitled "Smoking and Vaping Prohibited."

Section 1. Definitions

- (a) "Smoking or Vaping" means possessing a cigarette, e-cigarette, cigar, pipe or similar apparatus that contains tobacco, marijuana, cannabis or any other product that is lighted or burning: lighting a cigarette, e-cigarette, cigar, pipe or similar apparatus that contains tobacco, marijuana or cannabis or any other burning product that is contained in a pipe, cigar, cigarette, e-cigarette, or similar apparatus.
- (b) "City Building" means any building or structure owned, managed, operated, and/or leased by the City of White Cloud.

Section 2. Smoking prohibited locations

- (a) A person shall not smoke or use tobacco, marijuana or cannabis products in any city-owned: park, outdoor athletic complex, linear park, trail, pathway, cemetery, or beach unless specific areas are designated as allowed by resolution regarding tobacco only.
- (b) A person shall not smoke or use tobacco, marijuana or cannabis products in any city owned parking lots when used for community events unless specific areas are designated as allowed by resolution regarding tobacco only.
- (c) No person shall smoke in any City building.

Section 3. Signs

- (a) Signs may be posted where smoking and the use of tobacco, marijuana or cannabis products are prohibited, but the absence of posted signs does not invalidate this ordinance.

Section 4. Violations and penalties

A person who violates or fails to comply with this Article shall be subject to any one or more of the following:

- 1. Being asked to stop smoking or using the tobacco product;
- 2. Being asked to leave the premises;
- 3. Being responsible for a civil infraction punishable by a fine of first offense \$100.00, second offense \$200.00 and any violation thereafter.

Section 5. Effective Date This Ordinance shall take effect immediately upon publication.


