# H. New Business

1. Parcel 62-11-32-402 Rezoning request

Shears asked for a report of the meeting with staff and Mr. and Mrs. Franks. Williams explained she, Ridge and Twing met with the Franks' to go over the rezoning application. She said they also discussed the issue with the 2 acres and they understand they will need to apply for a variance. She added the Franks' additionally understand if the variance is approved they will also need to apply for a Site Plan Approval from the Planning Commission for the marihuana grow which includes sealed drawings. Twing clarified the two acres is because the property is industrial not because the use would be a grow. Fetterley noted this should probably be changed in the future. Ridge explained process that would need to occur to change the zoning ordinance. Twing suggested having two light industrial districts and one heavy industrial. Fetterley what would happen if the Board of Appeals denied the Franks request. Twing stated he thinks all along that street should be zoned industrial.

**Shears moved to approve** the request because there is industrial across the street and she thinks this parcel should be industrial. She added they very carefully decided where grows would be when planning for the future. **Seconded** by Steffes
