B. Unfinished Business

1. Signs

Twenty-six (26) signs and posts/hardware have been ordered from Dornbos Sign, Inc. The signs are 12'x12" that will show Soldier's Field, Old Plat, 1st Addition, 2nd Addition, 3rd Addition and 8"x8" signs that will show Block A, Block B, Block C, and Block D. Delivery is expected December 15, 2021; goal is to put the signs up in the cemetery Spring 2022.

2. Dead trees (added)

DPW Supervisor has a quote for work on the dead trees from Spring 2021; will look at getting updated quote to put in 2022-23 fiscal year budget.

C. New Business

1. Monument size for single grave

Discussion of the maximum size for a single grave monument/marker. Cemetery committee members were reminded a grave size is 4' (feet) wide by 12' (feet) in length. Per Curt Crandell, the maximum size for a single grave monument should not exceed 36" (inches) wide. A double is typically 48" (inches). The intent is to keep monuments/markers from encroaching on a neighboring grave.


