a. Yard of the Month

b. Smith Park Updates

Smith Park updates include wi-fi for public use, security cameras and working drinking fountains. T-Mobile grant was submitted for improvements at Smith Park, awaiting word on that grant. Roger Smith is working with the Knights of Columbus and the Fremont Area Foundation for funding a new flagpole, flag, and sign for the park.

c. Skate Park Equipment

City Manager received a quote to restore the equipment for the skate park, the amount was \$7626.00. Parks and Rec committee felt that amount of money could be used on other items that could be added to the park.

d. Mill Pond Dock Replacement

Dock needs replacement. DPW would like to use composite material due to its durability and the cost of cedar being pricey and requiring a lot of upkeep. Potentially a Fall 2022 project.

e. Swim Lessons update

Mary Arends Lamach was again the instructor for swim lessons. There were 35 participants total this year. Age groups are 3 years old and up.

f. Rotary Park Playground Equipment

Playground equipment is on order, estimated delivery is Fall 2022.

g. Campground annual visit

As part of the County campground lease, the parks and Rec committee are to visit the park annually. The annual visit was June 21st. Nic (Newaygo County Parks Director) showed those in attendance the progress the County has made with the park & shared plans for future improvements. Day Pass window stickers were given to City office staff for any City resident to gain access to the park for day use.
