Chad McGowen (WC Little League President) has set up an electrician; DPW Supervisor Barnhard met with the electrician and advised a contractor will need to bore the wire to the electric source. Little League/ their Contractor will need to pull an electrical permit through North Country Inspection Service.

c. Swim Lessons 2023 update

2023 Swimming lessons will be held July 24th – August 4th. Times are not established yet. Age groups are - & 4-year-olds, 5&6-year-olds, 7&8-year-olds, and 9 and up.

d. Dock update

Docks are at the DPW building. There are some structural issues that will require welding and center support to support the composite decking.
