**B. New Business**

**1. Personnel Committee follow up-DPW Full-Time Position**

Recommendation from the Personnel Committee to create a position in the DPW department. The position is meant to be a lead position within the DPW in the absence of the DPW Supervisor. The position involves operating equipment and performing manual labor to participate in the completion of assigned projects. Work is performed under the general supervision of the Department Public Works Supervisor. The intent of this position is to be mentored by the DPW Supervisor for future opportunities; A starting rate of \$22.30 per hour. Education/Training includes holding a Class A CDL or ability to attain within four (4) months of hire and encouraging the person in the position to obtain a municipal water license.

**Motion** by Dault **Supported** by Anuci to create a Lead DPW Maintenance Operator position starting at \$22.30 per hour with the understanding it will require a Class A chauffeur license and would encourage pursuing a water license.

**2. Personnel Committee follow up: Full-Time School Resource Officer (SRO)**

Personnel Committee is recommending to City Council to approve the 2023-2024 Full-Time SRO Agreement between the City of White Cloud and White Cloud Public Schools. The SRO work schedule will include traditional day time school hours as well as evening sporting events, not to exceed 1,520 hours per school year. The WCPS expense is estimated at \$37,620.00 paid in 3 installments; the City will provide a total of \$13,290.00 in wage, fringe plus additional expenses for the Program. The remaining 14 weeks in a year, the Officer will be on road patrol with all costs, benefits and additional expenses covered by the City of White Cloud. The rate of pay is \$24.75 per hour.

**Motion** by Becker **Supported** by Dault to approve the Full-Time School Resource Officer Agreement and an hourly pay rate of \$24.75.


