6. Pine Hill Water Tower Repairs: Bid Recommendation

2024 Water Tower Miscellaneous Repairs Project. Bids received for the repairs of the Pine Hill water tower came from L&T for project total of \$44,200.00 and LC United for \$39,000.00 to do sample tap, overflow pipe discharge modification, roof vent, roof handrail and painters railing and mud valve. City Manager recommendation to Council to accept the bid from LC United.

#### 9. WCSUA update

There are multiple issues, the main issue is a charter violation regarding ownership of the assets (Code of Ordinances, Chapter 7, Section 7.11 Disposal of Utility Plants and Property SECTION 7.11 DISPOSAL OF UTILITY PLANTS AND PROPERTY.

Unless approved by a three-fourths majority vote of the electors voting thereon at a regular or special election the city shall not sell, exchange, lease or in any way dispose of any property, easement, equipment, privilege or asset belonging to and appertaining to any municipally owned utility. All contracts, negotiations, licenses, grants, leases or other forms of transfer in violation of this section shall be void and of no effect as against the city. The restrictions of this section shall not apply to the sale or exchange of any articles of machinery or equipment of any city owned utility which are worn out or useless or which have been or could with advantage to the service be replaced by new and improved machinery or equipment.).

The WCSUA board was asked to have their attorney draft a maintenance and service agreement outlining the authority's responsibilities and the city will address the city charter issue by proposing ballot language for a vote of the public in 2024 for the city residents to vote on the utility assets.
