The EQ Department maintains names, addresses, conducts land divisions and combinations, creates new legal descriptions, maintains tax map layers, prints various assessing reports, prepares tax databases, and prints tax bills.

If Bartons is unable to schedule the project, the second recommendation would be to work with New Horizons Landscaping from Big Rapids.
