- 1. Engineer selection for Phase One presentation of all options for future of WC Dam The City Council members were given responses from Spicer Group, Wade Trim & Geosyntec Consultants, to questions asked of them by the City Manager. The questions asked were:
 - When would your team be available to present Phase One options to City Council?

- What options would your Phase One Proposal include?
- From your professional standpoint, would decommissioning the dam and removing it from regulatory oversight reduce or eliminate risk from a liability insurance standpoint in the same way as full removal?
- Can you provide any examples or documentation from other municipalities where decommissioning helped mitigate insurance concerns?
- Is there any additional information you would suggest I present to council to support their confidence in selecting your firm for this work?
- What is the estimated cost for your firm to sit down with the Mayor and City Manager to develop a full Phase One proposal including options, recommendations, and cost estimates and to prepare and present that proposal to City Council?

After reviewing the responses, City Manager Storms recommended Wade Trim based on the grant expertise shown during their slideshow presentation from conceptual through completion of restoration, funding and reporting. In the presentation they showed a restorative vision for the option of dam removal, they were forthcoming with challenges, gave realistic timeframes and avoided over-promising as well as their timely compliance up to this point.
